## Member Code of Conduct

These guidelines will ensure the enjoyment and safety of all members and their guests who visit the Community Recreation Center.

- Appropriate attire shall be worn at all times.

- Members shall comply with all instructions from Center staff.
- Members shall sign in for use of the technical center, gymnasium, and fitness center.
- Children 12 years and under must be supervised by an adult.
- Children under 16 years of age are not allowed to use the Fitness Room.
- Guests are welcome when accompanied by a member and when the proper guest fees have been paid. Members are responsible for the behavior and actions of their guests.
- All classes, programs and events, unless otherwise designated, are for members only.
- Membership may be suspended or revoked for improper conduct or language towards others, including Center staff.
- The City is not responsible for lost or stolen items. Please use the lockers located by the gymnasium to secure your personal valuables.
- Lockers are for temporary use only. For security reasons, all lockers will be emptied nightly and the contents will be discarded.
- Food and drink are permitted in designated areas only.
- Courtesy phones are available to members and their guests. Extended calls are not permitted.
- Any person under the influence of alcohol or drugs will not be permitted in the Center or on the grounds.
- Smoking is not permitted in the Center.

However, due to the nature of the Internet, some sites that might be considered as objectionable may not be blocked. In the event an objectionable site should appear, please notify a Community Recreation Center employee immediately. These services are provided for personal use only and if any of these provisions are violated, access to these services will be denied.

- Internet activity is monitored by a web filtering application in order to provide a safe and positive Internet experience. The City makes no attempt to identify individual users or their Internet activities unless the terms of this agreement have been violated.
- E-mail and Internet accounts are to be accessed only by the authorized owner of the account.
- Use of E-mail and/or the Internet for commercial use or profit is prohibited.
- Users must abide by copyright, contract and other local, state and federal laws, and city directives and policies.
- Intentional use of E-mail and/or the Internet to access, transmit or process obscene material, inappropriate text, graphic files, or any form of sexual, racial, ethnic, violent or harassing communications are prohibited.
- Files, programs, applications, etc. cannot be downloaded from an E-mail attachment or from the Internet to a City-owned computer.

### **E-mail Privacy**

All users should be aware that confidentiality of E-mail cannot be assured and that any communications which need to remain confidential should not be sent over the Internet.

### **Agreement Acceptance**
